Commitment to Fans Reminder

Before outlining the proposed structure of STFC below is a reminder of the commitments made to supporters in Clem Morfuni's response to TrustSTFC's open letter:

My initial **plan** is as set out below:

Obtain agreement, in principle and subject to contract, to purchase the shares at STFC and immediately carry out appropriate due diligence to ensure we are aware of the debts, financial position and issues facing STFC going forward.

Review and seek to resolve debts that STFC has and invest in the Club to ensure it has a stable and proper financial footing.

Review the football management structure of the Club and make appropriate changes to ensure that we can build stability and make improvements to the playing side of the club.

Review the commercial management of the Club and make appropriate changes to grow commercial revenue which can then be reinvested in STFC.

Invest in management staff that will provide regular engagement with our supporters, media, and the local community.

Provide quarterly management and financial updates to provide transparency to the Trust on the financial position and performance of STFC.

Commence monthly meetings with representatives from the Trust, STFC and Swindon Town Official Supporters Club. Minutes of these meetings will be circulated and kept as a record to measure future performance against stated aims and goals.

Restart the plans with supporters to purchase the County Ground from Swindon Borough Council.

Set out plans for staged improvements and developments at the County Ground so that it is a multi-purpose high quality stadium fit for purpose for the 21st Century

To prepare and file full annual accounts regularly and on time (audited where required).

To answer all questions from all local media outlets and never seek to censor or avoid proper questions.

My **commitments** to supporters and the wider community of Swindon and surrounding areas:

I will always be open and transparent on all matters in regard to STFC.

I will provide regular engagement and communication with the supporters and the wider community of Swindon and surrounding areas.

I will build a sustainable future for STFC, investing in the infrastructure of the Club with the aim to take it forwards to being a stable Championship Club.

I will build a sensible structure and present a 1, 3, 5 and 10 year plan that will aim to carry and develop STFC into the future.

Further to all of the above, I will not take a salary or any personal fee payments from the Club for the time I own a controlling interest in the club

January Executive Summary

- Historic external debt now down from c£7.5m to c£970k under CM's ownership
- Plans to buy County Ground moving at pace with exchange due by end of January and discussions on funding purchase of County Ground by Nigel Eady Trust Fund progressing well.

 TrustSTFC members have approved their part in the JV and purchase. All matters on track
- Trust and OSC continuing work on ideas to improve atmosphere at the County Ground
- Work to integrate STWFC and plan for the 23/24 season continues
- Club, Foundation, Trust and OSC will work together to prepare plans for STFC to have a strong environmental agenda going forwards with environmental sustainability now very much on the agenda
- STFC Community Foundation continuing strong work to support local community with Dementia Café, Super Robins Mental Heath team and progress with new covered training facility progressing well



January Minutes & Actions Review

1.1 The minutes and actions from the previous meeting were agreed. The following open actions were discussed:

Action – Discussions are continuing and will look to loop in the STFC Community Foundation into these discussions. AC updated that the OSC do not currently have the resources to drive the fanzone. CM asked AC, SW and JC to set out their thoughts and a plan re a fanzone at the County Ground. Thoughts and feedback provided. JH to follow up with Premier League who have discussed providing funding for clubs via Community Foundations

Action - RA and JS will meet to discuss the Club's marketing and data needs. Update, initial meeting held with follow up in progress. Club need to work with Ticketmaster to ensure end to end journey tagging is live and working before investing in digital marketing spend. Update – tagging now implemented RA to follow up with AP and JS with new ticketing team – work to explore continues

Action – AP to look at the possibility of a joint statue for Don Rogers and John Trollope – Update – Trust now finalising order for statue

Action - SW to provide detailed plans and cost estimates for Museum. Meeting with CM and Trust members during September. Meeting held with initial plans agreed and estimates have been sought

Action – OSC, Trust and STBL and other fan groups to work together to see how we can improve atmosphere at the County Ground to support the team – meeting with supporters groups now booked in

Action RA and JW to provide an STFC Business Directory and Diary of Events for Sponsors/Partners – in traction

Action – RA to arrange meeting with CM to discuss STWFC plan for 23/24 – meeting due later in January

Action – RA to share a 5 and 10 year Plan. - in traction

Action – RA to look into Data Privacy question – in traction



January Minutes & Actions Review

- 1.1 The meeting started with RA going through the minutes and actions from the previous meeting as noted on previous page.
- 2.1 RA provided the legal update and noted that Centerplate petition was dismissed with STFC putting the amount it believes is due into a Solicitors account and are awaiting a response from Centerplate. The disputes on the legal costs due in respect of the DPDS debt continues. The Mercedes debt remains an issue to resolve.
- It was noted that the Club is trying to close out the FA Charges whilst Power and Standing are looking to defer until the Standing v Power case is heard which will be sometime in 2023. It looks likely that the delay in the Standing v Power case will defer the outcome on the FA charges.
- County Ground deal continues with Exchange agreed for 31/1/2023. Legal documents are progressing to finalise the sale, lease and JV agreements. Positive discussions with the Nigel Eady Trust Fund in respect of them funding the purchase of the ground which would be an amazing legacy from Nigel. The Supporters Trust have sought and received approval from their members to purchase the CG and are now readying their share proposal.
- 3.1 RA then provided the business and financial update. Noting that the overall external historic debt had now reduced from c£7.5m when CM took over to c£970k. With all repayment plans on track and the majority of the debt owed to the EFL on interest free loans.
- 3.2 RA noted the push to get enough demand to open the Stratton Bank for Charlie Austin's return game v Grimsby. The Club continues to work on school and youth football ticketing initiatives with Trust STFC and the STFC Foundation where sponsorship/partnership opportunities exist to expand this important initiative. More stock of 1st, 2nd and 3rd kits are in store and letters and numbers given strong demand for Austin #11 shirts.
- 3.3 Sponsorship and Partnership opportunities remain and Commercial Manager, James Watts is driving these. DC is progressing discussions with Sponsors/Partners to gain their feedback and ideas and is looking at forming an STFC business club. Conferencing and Catering bookings for non-matchdays are continuing to improve
- Club is looking at ways it can improve its environmental impact and become more sustainable. More plans in this space will follow soon. Club will link up with work that TrustSTFC and the OSC are also doing in this space.
- 3.5 RA noted the Academy and Safeguarding updates. DC noted the discussions we are having in providing financial planning educations for Academy players which will help them manage their finances.
- 4.1 SB provided the STWFC update and noted that budget plans for 23/24 are progressing well with strong support from MC. STWFC will meet with CM and RA later this month to go through the integration plan and the budget for 23/24 season. Plan is for more games at Foundation Park and the County Ground. James Watt is working on driving 23/24 sponsorship opportunities for STWFC team.
- AC provided the OSC update with answers to questions updated in the OSC slides below. As part of the update CM reiterated the desire for the Club to be promoted this season which was a key part of bringing Charlie Austin back to STFC and illustrates our ambition.



January Minutes & Actions Review

- JS provided the Trust update and noted the progress on members voting to approve the purchase of the County Ground. The details of how to obtain shares in the Trust and the County Ground are online and a brochure will also be produced for any who cannot access online.
- 6.2 Plans on the statue of Don Rogers are progressing well with meetings to be arranged to discuss the location of the statue. JS noted that the Trust, OSC and Club will meet soon to discuss ideas to improve the atmosphere in the County Ground on match day.
- One question raised by Trust Members was how much rent the Club will pay compared to the current agreement. The rent will be 50% less reflecting the Club will own 50% of the ground. The rent will be paid to the JC and will be re-invested into the ground with JV approval.
- 7.1 DC noted that no questions or feedback from sponsors this month. A meeting to discuss the formation of the STFC business club is due on 20 January. DC noted that he would like to thank Matt Barnes of Barnes Coaches for their support of STWFC in providing discounted coach travel and use of the Team coach where possible.
- JH gave the Foundation update noting that it is the EFL Community week of action with the Dementia Friendly memory café on Thursday 19th 10.30-12. JH also noted that the Super Robins Mental Health team have a game coming up v Newport. JH also noted that the Wyvern Salisbury school representing STFC in the EFL Girls under 13 National Cup have the semi-finals coming up at Walsall's Bescot Stadium.
- JH also noted the EFL Green campaign which goes live on 4 Feb and the Foundation are organising volunteers for a little pick. RA noted that the Club, Foundation, Trust and OSC will join up on Green initiatives as the Club looks to make a big push in this area.
- 8.3 JH noted that the new covered facility at Foundation Park should be ready in March which will provide excellent new facilities for the community.

The first scenario requires a virtual rebuild every season, some years with relative success like last season but invariable will often produce variable results although we might find a gem to develop and sell. The second scenario relies on keeping the vast majority of a proven squad and adding a few where required to maintain a competitive team capable of promotion push. As long as i am alive my season ticket purchase is not in doubt however i would like the club to be open and honest so that supporters can adjust their expectations if we are perusing a Crewe Alexander type model. For what its worth i would be very disappointed if our ambition was stability and ground purchase at the cost of on the field competitiveness. It would be nice to see my Swindon have a couple of promotions before i pop my cloggs. Stewarding	One thing I have noticed increasingly this season is the somewhat intrusive stewarding at home matches. The only time that one should really be aware of a steward is if someone is behaving seriously out of order or if there is a major incident. Recently however it seems that stewards are going out of their way to get involved in pretty minor things and making mountains out of molehills. It is at best overzealous and at worst downright malicious. A football ground has never supposed to be a sanitised, soulless environment but it appears that the stewards have been told to clamp down on anyone attempting to create any kind of atmosphere. I'm not sure how true this is but I have been told that the company running the stewarding are basically using nightclub bouncers rather than event stewards which may go some way to explaining their behaviour.
