Considering our apparent cash flow issues, I'd have thought it sensible to maximise revenue by having stock of items that clearly sold well? Yes, new stock is coming into the club shop at the moment and over upcoming months – It's an ongoing process. There have been various issues from the kit manufacturer regarding logistics and timescales which has impacted stock levels. Would Anthony or Clem like to say anything in reference to Anthony's comments regarding the value of season tickets? There seems to be a disconnect between Anthony's comments to Vic Morgan and the comments in December's advisory board meeting. Anthony Hall and Clem Morfuni are not disconnected on the season tickets. Anthony Hall feels that his comments have been misinterpreted although fully understands why and lessons on communication have been learnt. Anthony would like to offer his sincere apologies to our season tickets holders. There appears to be a lot of negativity amongst some of the fanbase at the moment mostly around the on-pitch performance and the fact we are losing experienced players and replacing them with inexperienced players. This approach although ok, does make me wonder if the strategy is still on the footballing side to have a team with a mix of experience and youth, is this still the case? Yes, it is. Jamie Russell will speak of this in the Fans Forum (30-01-24), it's a blended mix of both experience and youth. Hopefully fans can see this from the players that we intend to bring in during the January transfer window. I would like to ask the club why the disabled officer has been changed from Caroline Lane to James Watts, from the outside and from feedback received Caroline Lane was doing an amazing job in the DLO role and so lots of people are surprised that this change has been made. Changes in responsibilities of staff occur all the time and the club have got James Watts to undertake this role in the interim until they find a permanent replacement for this role. It's taking up more and more time and so needs a permanent owner ideally. I see we are losing our first team physio and looking to recruit a new one already, is there a reason Jack the physio has left so soon, it seems odd and a worry we are losing key roles so quickly. There are no issues, he is leaving for personal reasons. I would like to pass on my thanks to the club and supporters club for the wonderful Christmas support they showed the community including the visits to the hospital from the first team women's team etc. my child was in hospital at the time, and you will never know how much of a positive impact to his recovery this had. This sort of community activity and supporting the less well off or people in

hospital in Christmas is a wonderful way for the club to get out into the community, is this something the club might consider extending to older members of the community as well as more regular hospital visits. Thank you and your team was a credit to the club who visited.

Yes, and we are working on this. And thank you. The club wants to be a presence in the community. We are making plans for the Women's team to go out to schools over the next few months. With more and more schools setting up girls' teams, our girls will be visiting schools to talk about their experiences in the game.

My son is a regular to the junior reds room since it was refurbished and I have to say this is a superb addition to club facilities on match days, the kids love meeting up in the room and enjoying the facilities and meeting players. Huge congratulations to the club for providing this and to Caroline for running this. If fans would like to support the room by donating goods or money to support it is this something that can be done and how?

Why are the clubs view on some of the online fans that seem to want to continually berate and attack the club and do they know why they do this?, We all know times are tough and things have not been good on the pitch but it seems counterproductive as fans to behave in this way.

I have been watching town for over 40 years and both myself and people who sit around me in the DRS are disgusted to see this sort of behavior and anger and I wondered if the club had reached out to these fans and groups to speak to them to understand their reasons and anger? They hide online but if the club offered them the chance to speak personally in the club I bet they would turn it down as they would have nothing to moan about then. This must be impacting the players on the pitch and as fans we need to support the players in my view, there is nothing wrong with outlining frustrations and opinions in the right way but some of the language tone and disgraceful attacks and bullying behavior towards club employees and also even some fans witnessed is simply unacceptable. I feel these people need to discuss their anger with the club hierarchy and a resolution found ASAP for the good for the club.

The club values and encourages feedback from fans, whether positive or negative, as all feedback can be constructive and beneficial.

We also welcome the opportunity to address any concerns or issues, the fans forum is a great platform to raise and address these issues in a productive and collaborative manner. If fans wish they can also reach out directly to the club to discuss these concerns.

We have had some questions regarding specific fan groups/individuals and we do not want to name these, we will not be printing details, but we (Club, Trust or OSC) are willing to communicate or meet directly to discuss any issues.
